



Instructions for Declaration of Domicile

Recording Customers:

- When filling out the Declaration of Domicile form, only one form per household is required.
- The form must be completed, but NOT signed unless in front of a Notary Public.
- Our office offers Notary Services for a \$10.00 fee
- If mailing, you must include a self-addressed stamped envelope for the return of your recorded document

Fees:

- Recording: \$10.00
- Notary: \$10.00 (if notarized by Clerk of Courts Official Records Services Office, MUST be in person)
