## **Claiming Surplus Funds**

#### Previous owner

To claim surplus funds you must submit the following prior to the expiration of the claim period:

- Notarized Affidavit of Claim
  - o Must reference the tax deed number
  - o Must state your interest in the property and/or surplus funds
  - Must be properly executed with the date, complete notarization and two witnesses
  - Must include your current mailing address
- Legible copy of a government issued photo identification
  - o Must be a valid Driver License, ID card, or Passport that shows address and DOB
- Contact information with which you may be reached for questions or additional information regarding your claim if necessary
  - o Email, phone number(s) and/or different mailing address
- Other information as needed

Please remember to reference the tax deed number on all claim documents, id's, correspondence and emails submitted to our office.

# Heir/Beneficiary/Executor of the Estate of the previous owner

To claim surplus funds you must submit the following prior to the expiration of the claim period:

- Death Certificate of previous owner
  - o Must be a certified copy or an original
- Probate documentation for the estate
  - o Must reference the tax deed
  - o Must be filed in Florida (preferably Lee County where property is located)
  - o Must list all heirs/beneficiaries and their entitlement
  - o Must be a certified copy Order from the court
  - o If case is not finalized must be a certified copy of the Petition
- Notarized Affidavit of Claim

- o Must reference the tax deed number
- o Must state your interest in the property and/or surplus funds
- Must be properly executed with the date, complete notarization and two witnesses
- o Must include your current mailing address
- Legible copy of a government issued photo identification
  - o Must be a valid Driver License, ID card, or Passport that shows address and DOB
- Contact information with which you may be reached for questions or additional information regarding your claim if necessary
  - o Email, phone number(s) and/or different mailing address
- Other information as needed

### Lien Holder

To claim surplus funds you must submit the following prior to the expiration of the claim period:

- Copy of recorded lien
- Notarized Affidavit of Claim
  - o Must reference the tax deed number
  - o Must state your interest in the property and/or surplus funds
  - o Must indicate amount currently owed
  - Must be properly executed with the date, complete notarization and two witnesses
  - Must include your current mailing address
- Proof of officer's authority to request funds (if claiming on behalf of a business)
- Legible copy of a government issued photo identification
  - o Must be a valid Driver License, ID card, or Passport that shows address and DOB
- Contact information with which you may be reached for questions or additional information regarding your claim if necessary
  - o Email, phone number(s) and/or different mailing address
- Other information as needed

### Third Party

To claim surplus funds you must submit the following prior to the expiration of the claim period:

- Notarized Assignment or Power of Attorney
  - o Must reference the tax deed number
  - o Must state the interest in the property and/ or surplus funds
  - o Must indicate amount of surplus funds being assigned/claimed
  - Must be properly executed with the date, complete notarization and two witnesses
- Notarized Affidavit of Claim
  - o Must reference the tax deed number
  - o Must state your interest in the property and/or surplus funds
  - o Must be properly executed with the date, complete notarization and two witnesses
  - o Must include your current mailing address
- Legible copy of a government issued photo identification for each party
  - o Must be a valid Driver License, ID card, or Passport that shows address and DOB
- Probate documentation for the estate (if applicable)
  - o Must reference the tax deed
  - o Must be filed in Florida (preferably Lee County where property is located)
  - o Must list all heirs/beneficiaries and their entitlement
  - o Must be a certified copy from the court of final order
  - o If case is not finalized must be a certified copy of the Petition
- Contact information with which you may be reached for questions or additional information regarding your claim if necessary
  - o Email, phone number(s) and/or different mailing address
- Other information as needed
