**TOURIST DEVELOPMENT TAX - RETURN AND INSTRUCTIONS**

1. GROSS RENTAL RECEIPTS: Enter the total dollar amount of short term rentals (including rent, cleaning fee, pet fee, and any mandatory fees) for rentals six months or less.
2. EXEMPT RENTAL RECEIPTS: Enter the dollar amount of any rentals covered by State and/or Federal Certificates of Exemption.
3. TAXABLE RENTAL RECEIPTS: Enter the dollar amount of taxable rental receipts (line 1 minus line 2).
4. TOTAL TAX: Enter the total Tourist Development Tax collected – 5% of line 3.
5. PENALTY: After the 20<sup>th</sup> day following the reporting period, contact (239) 533-2190 for penalty rate.
6. INTEREST: After the 20<sup>th</sup> day following the reporting period, contact (239) 533-2190 for the current interest rate.
7. (LESS PRIOR CREDIT): If applicable
8. TOTAL AMOUNT DUE: If paid timely, remit amount shown on line 4 (Total Tax 5%). If Late: Add lines 4 (Total Tax 5%) 5 (Penalty) & 6 (Interest). Line 7 (Less Prior Credit) if applicable.

Notice: If your account is habitually delinquent, which is defined as more than two late filings in a 12 month period, our Enforcement action to collect the amount due may include, without delay or additional notice, placing a lien on the property of your business and/or freezing your bank account(s) pursuant to Florida Statutes, Sections: 212.03(5), 212.04(7), 212.14(1), 212.15(4) and 213.731.
