## PROBABLE CAUSE STATEMENT

On July 4, 2022 at approximately 1721 hours while working as a uniform patrol officer for the Cape Coral Police Department, I responded to Walmart located at 3920 Santa Barbara Blvd, Cape Coral, Lee County, Florida, in response to a disturbance in progress.

Upon arrival, officer D. Little made contact with the victim, Evelyn Gonzalez. Gonzalez stated in a written statement that Roman Slowick was in the store causing a disturbance by yelling in the store. Gonzalez described Slowick as wearing a red ball cap, white tee shirt and blue jeans. Gonzalez recognized Slowick from previous encounters with him in the store, and knew him by name. Gonzalez stated that Slowick was upset and grabbed a cigarette display causing a mess. Gonzalez stated that as she was attempting to pick up a pack of the cigarettes, Slowick grabbed her left hand and twisted her middle finger causing swelling.

I made contact with Slowick to whom I have had numerous encounters with in the past and am familiar with his behaviors. Slowick is deaf and only communicates in written form however has a hard time reading or writing and becomes upset. My encounter with Slowick today, he was belligerent and uncooperative.

I then detained Slowick in CCPD issued handcuffs that were double-locked and escorted him to my marked patrol vehicle without incident.

Photos were taken of Gonzalez's finger.

Due to Slowick being uncooperative and not willing to explain further on the incident, The physical swelling on Gonzalez's finger, I found probable cause for the arrest of Battery on a 65 or older, F.S.S. 784.08 2C

Walmart wished Slowick to be issued a trespass warning at this location as well. Slowick was issued A trespass warning for this location on NTA 240529

Slowick was transported to LCD where he began yelling and was taken in as disorderly by LCSD in apparent good health.
