

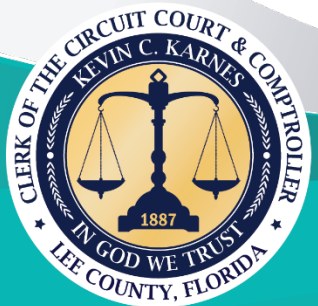

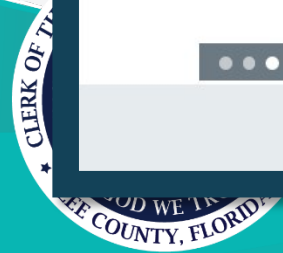

Compliance Options: 30-Day Extension



Customers may request a one-time, 30-day extension on traffic violations

Citation must be within the first 30-days of issuance

Cannot be delinquent/past due

Can be requested in-person or over the phone

Not currently available online

Customer can pay amount owed in full or enter into a payment plan

Within/by the extended due date

Note: Excludes cases that require a mandatory court appearance or already have a hearing scheduled.



Compliance Options: Payment Plans

**Payment arrangements are offered for all
Traffic and Criminal case types**
(Excludes active county/state probation)



Set-up fee gets assessed

Currently \$25 | Per case

1st payment is due when the plan is established

Choose the due date that works best for you

If active driver's license suspension:

Suspension gets cleared when the plan is established

**Failure to comply with the plan will result in the issuance of a
driver's license suspension**



Compliance Options: Payment Plans

Regular Guidelines

Total Amount Owed	Time to Pay
	Monthly
\$300 or less	3 months
\$301 to \$700	6 months
\$701 to \$1200	12 months
\$1201 to \$2000	18 months
\$2001 and above	24 months

Indigent Guidelines

Total Amount Owed	Time to Pay
	Monthly
\$300 or less	6 months
\$301 to \$700	12 months
\$701 to \$1200	18 months
\$1201 to \$2000	24 months
\$2001 to \$3500	30 months
\$3501 to \$5000	36 months
\$5001 to \$7000	48 months

Compliance Options: Community Service

Must complete an Application or Compliance

Provided by the clerk | Qualification required

Rate of \$10 per hour

Applicable to fines only

Excludes court costs & fees



Community Service Requirements:

- Must be a non-profit organization
- Must bring proof to the Clerk's office on the organization's letterhead with
 - Organization Name, Address and Phone number. MAY NOT be handwritten
- The letter must have :
 - Your name, case number, date(s) of service and hours you served
 - Name of Supervisor, signature, and phone number
 - **Signature of Supervisor must be Notarized.**

Example for hours performed:
3/10/14 – 2 hours
3/11/14 – 5 hours

A yearly *Driver License Reinstatement* event geared to help citizens with suspended licenses

Governed by F.S. 322.75

Allows for the waiver of qualifying fees on overdue fines

Requires State Clerk's offices to select one or more days

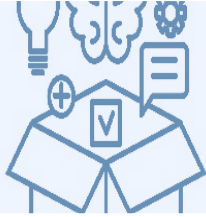

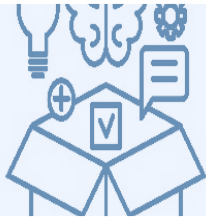

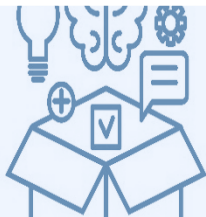
