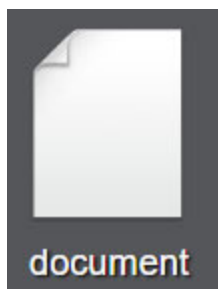




Step-by-Step instructions to Search for Respondents in Domestic Violence Injunction Judgments Involving Minors per Section 28.2221, Florida Statutes, as Amended 7/1/2024.

1. Open the [Official Records search](#) above or click the "Search Official Records button"
2. Click on "document"



3. Before conducting a search, you will be required to accept the disclaimer for conducting an Official Records search

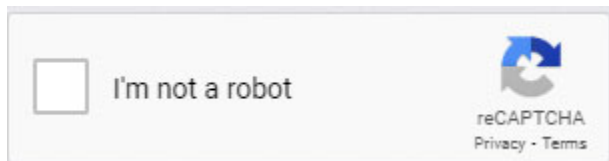
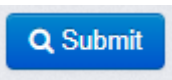
