We have audited the accompanying Statement of County Funded Court-Related Functions, Section 29.0085, Florida Statutes (Statement) of Lee County, Florida (County) for the year ended September 30, 2014, and the related notes to the Statement.

Management's Responsibility for the Financial Statement

Management is responsible for the preparation and fair presentation of the Statement in accordance with Sections 29.008 and 29.0085, Florida Statutes. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of the Statement that is free from material misstatement, whether due to fraud or error.

Auditors' Responsibility

Our responsibility is to express an opinion on the Statement based on our audit. We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Note 1- Reporting Entity

Lee County, Florida (County) is a political subdivision of the State of Florida. It is governed by an elected Board of County Commissioners (Board), which is governed by Florida Statutes and regulations. In addition to the members of the Board, there are five elected Constitutional Officers: Clerk of the Circuit Court, Property Appraiser, Tax Collector, Sheriff, and Supervisor of Elections.

The Statement of County Funded Court-Related Functions, Section 29.0085, Florida Statutes (Statement) is prepared and submitted to the State of Florida's Chief Financial Officer in accordance with Sections 29.008 and 29.0085, Florida Statutes (Statute). The Statement only contains the revenues and expenditures as required by the Statute and is not intended to present the assets, liabilities, equity, revenues and expenditures of Lee County, Florida, for the year ended September 30, 2014, in accordance with accounting principles generally accepted in the United States of America.

The accompanying Statement is presented using the modified accrual basis of accounting. Under the modified accrual basis, revenues are recognized if they are measurable and available for use during the year. Available means collectible within the current period or soon enough thereafter to pay liabilities of the current period, which is considered to be sixty days. Expenditures are recognized in the period liabilities are incurred.
