**Clerk's Affidavit:** Prepared when an error in a recorded document exists (typographical error), for example, there is an error in the Plat Book/Page reference in the legal description. This affidavit is not prepared by the Lee County Clerk of Courts' Office.

The Affidavit should have the following information:

Preparer's information (name and address)

The error that is being corrected, including the book type, book/page, and/or instrument #

The correct legal description

Fees:

Recording Fee (\$10.00 first page and \$8.50 each additional page)

Notary Fee (\$10.00)

Name Search Fee (\$2.00 per name search)

Document Search Fee (\$2.00 per book/page, or instrument number search)
